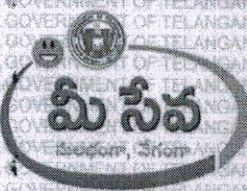

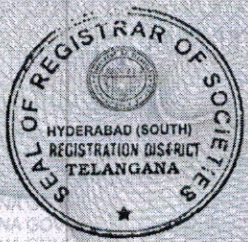

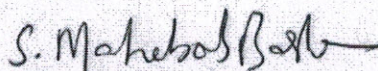

SUBSCRIPTION** : Admission fee is Rs. 50/- and Annual
Membership fee is Rs. 100/- per member
4. **GENERAL BODY**
 - (i) Annual General Body will meet once in a year i.e. in the Month of April
 - (ii) **FUNCTIONS:**
 - a) To pass the budget for the ensuing year and approve expenditure statement of previous year.
 - b) To approve the reports of the activities of Society.
 - c) To elect the Executive committee etc .
 - d) To appoint Auditor
5. **Executive committee:**
 - i) Executive committee shall consist of Seven (7) members and out of them, the following office bearers shall be elected by the EC
 - a. President,
 - b. General Secretary,
 - c. Joint Secretary and

d. Treasurer

and the remaining persons all the Executive Committee Members.

ii) The members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see that the said signatures of the out going Governing Body tally with the annual list as filed with the Register of societies before 15 days the succeeding month in which elections were held

FUNCTIONS OF THE EXECUTIVE BODY AND OFFICE BEARERS

1. PRESIDENT:- He Presides over all the meeting of the both General Body and Executive Committee, he can caste his vote in case of tie . He can supervise all the branches of the society.

2. Vice PRESIDENT:- He shall assist the president in discharging his duties in the absence of the President he shall perform the duty of the President as entrusted by him.

3. SECRETARY: - He is their Executive Officer of the society and custodian to all records relating to the society and correspondent on behalf of the society. He has to take on records of all minutes of the society to conveyed both the bodies of the society with the permission of the President. He guide the treasurer in preparing the budget and expenditure statement of the Society.

4. JOINT SECRETARY: - He has to do the work entrusted by the executive committee. He has to assist the Secretary in discharging his duties, in the absence of the secretary, he can perform the duties of the Secretary.

5. TREASURER: - He is responsible for all-financial transactions and funds of the society. He has to maintain accounts properly along with the vouchers he has to prepare the accounts of the society jointly with the Secretary or President.

6. OFFICE BEARERS: - They are the responsible person to attend to such activities of the Society Which the Executive Committee entrust to them.

7. QUORUM: - Half of the total members for General Body Meeting and $\frac{1}{4}$ for Executive Committee Meeting.

8. Funds of the Society:

The funds of the society shall consist of the following:

- i. Contribution by the members.
- ii. Donations from other sources.
- iii. Nominal Fee charged by the society for services rendered.
- iv. Income from investments and receipts from other sources.
- v. Grants from the government.

Funds of the society shall be spent towards the attainment of objects of the society only.

The Management committee will decide by resolution to open a bank account of the society and the persons authorized to operate the account time to time.

9. Audit:

- i. The account of the society shall be maintained or caused to be maintained by the Management Committee members of the society for recording all its receipts and payments and of the properties of the society.
- ii. The accounts of the society shall be audited annually by the chartered accountant.

10. Amendment by Law:

- The General Body of the society is competent to amend the rules and bye laws of the society on the request of the Management committee.

11. Winding Up:

- In case the society has to wind up the property and funds of the society shall be transferred or paid to some other institution with similar objects having registration u/s 12A of the Income Tax Act, 1961.

12. None of the office bearers of the society shall be allowed to use funds or the assets of the society or allowed to derived any benefit either directly or indirectly from the society as stipulated u/s. 13(1)(C) of the Income Tax Act, 1961.

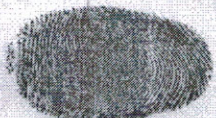
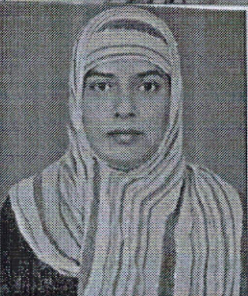

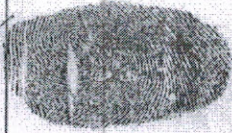
